Minutes of the Parish Council Meeting held in the Village Hall on Monday 20th July 2015

Public participation

Rev and Mrs Rogers came to the meeting to inform the Council that although having been granted planning permission for the wall they have delayed the start of the work. They insist they have letters to prove they own the land in question but were not prepared to show them to the Council. They went over several issues dealing with the footway, health and safety issues regarding the bench and the fact that Mrs Coyle had not contacted them.

Cllr Green stated that their comments would be noted.

Cllr Peter Watson spoke to them at this point informing them that it was up to them to prove ownership, and suggesting if they had this they should show it to the meeting. As this was not done he advised them to prove ownership before work starts. Cllr Green suggested that once more information is obtained a meeting could be arranged.

A Parishionner asked what is happening about the siting of the bench, this can't be sorted until the position of the wall id decided.

County Councillor's report

Cllr Davison reported that he went through files at County Hall on 49, Main street and nowhere does it say that the householders own the land. He found evidence that Highways had refused permission to put in a step. He will check with Mr S Tilley as to exactly what he said to the householder. Cllr Davidson has also spoken to to Frank Briggs who was at the bench opening event.
