Minutes of the Parish Council Meeting held in the Village Hall on Monday19th December 2016

Present: Cllrs Mrs Record, Green, Bowles, Harper, County Cllr Rob Davison and District Cllrs Peter Watson and Mrs Hilary Coyle

County Councillor's report

Cllr Davison reported on a walk around the village on 30th November with Cllr Mrs Record looking at problems - the triangle in Park Lane will need to be kerbed to protect it from traffic. The faulty sensor on the light by the triangle in Trent Lane has now been fixed. They also looked at the state of the grass verge by the allotments – this needs to be infilled and possibly a grid placed there which allows the grass to grow through. The surface in Old Gate Avenue needs addressing.

Cllr Davison has now set up a group with representatives from the villages to install local information signs on the canal to encourage canal users to use local services – a design is being drawn up.

District Cllr's report

Cllr Watson reported on the Local plan part 2, 72 comments have been received – there will be no substantial amendments and it will go to full Council at the end of January with a public enquiry around Easter and be adopted by mid summer.

He reported that at the Area Forum access onto the A514 from Weston and Aston was discussed. It may be possible, if one of the footpaths was removed, to put a turning bay in – although this may not be the solution for traffic from Weston and Aston.

High speed rail – the new plan follows the line of the M/A42 east of the airport through Ratcliffe and Trowell.
