County Councillor's report

Cllr Davison reported that the resurfacing of Old Gate Avenue has been
done to a good standard and signage on Swarkestone causeway is being
installed this week to deter HGV's from using this route. He is to attend
a meeting tomorrow looking at the problems at Cuttlebridge.

District Cllr's report

Cllr Atkin reported that Richborough Homes will not be contesting the
decision re the proposed development on Weston Road, Aston on Trent
– although they do have until 9/5/17.

He reported that he had received a complaint from The Coopers Arms
about gates from the sheltered housing in Wilmot Avenue opening onto
the footpath.
