2. Within 28 days of the provisions of an authority's code of conduct being adopted or applied to that authority or within 28 days of his election or appointment to office (if that is later), a member must register his financial and other interests in the authority's register maintained under section 81(1) of the Local Government Act 2000 by providing written notification to the monitoring officer of the responsible authority.
3. A member must within 28 days of becoming aware of any change to the interests specified under paragraphs 1 and 2 above, provide written notification to the monitoring officer of the responsible authority of that change.
